EXTENSION OF TIME TO COMPLY WITH OBLIGATIONS UNDER THE TIONG AIK CONSTRUCTION PTE LTD (IN LIQUIDATION) ("TAC") DEBT RESTRUCTURING AGREEMENT

Unless otherwise defined herein or the context requires otherwise, all capitalised terms shall have the same meanings as defined in the Company's previous announcement dated 1 April 2025.

The board of directors of TA Corporation Ltd. (the "**Company**"), and together with its subsidiaries, (the "**Group**") wishes to inform that the parties to the TAC Debt Restructuring Agreement have agreed to extend the time for the Company to procure that the Assignment of Proceeds to be made from TACC (C.R) Ltd to TAC by 30 June 2025 as more time is required for the liquidators of TAC to seek legal advice from its Cambodian counsels regarding the terms of the deed of Assignment of Proceeds and the parties to finalise the deed of Assignment of Proceeds.

Further announcements on the Assignment of Proceeds will be made in due course as and when appropriate, including if there is any adjustment or amendment to the terms of the deed of Assignment of Proceeds.

Trading of the Company's securities on the SGX-ST had been voluntarily suspended by the Company on 17 July 2023.
