MONTHLY UPDATE PURSUANT TO LISTING RULE 704(23)

Unless otherwise defined herein or the context requires otherwise, all capitalised terms shall have the same meanings as defined in the Company's previous announcements dated 1 April 2025, 8 April 2025, 23 April 2025 and 16 June 2025.

The board of directors of TA Corporation Ltd. (the "**Company**"), and together with its subsidiaries, (the "**Group**") wishes to update that there have been no material developments since the Company's last monthly update on 30 May 2025, save for such update(s) as may be announced since then and in this announcement.

(1) Extension of time to comply with obligations under the TAC Debt Restructuring Agreement

Under the TAC Debt Restructuring Agreement, the Company is required to procure that the Assignment of Proceeds is made from TACC (C.R) Ltd to Tiong Aik Construction Pte Ltd (in liquidation) ("**TAC**") no later than 15 May 2025, which was subsequently extended to 30 June 2025. The Company wishes to update that it has obtained a further extension of time from the liquidators of TAC to comply with the abovementioned obligation by 14 July 2025 as more time is required for the Company to consider and finalise the terms of the deed of Assignment of Proceeds.

(2) Submission of the Resumption Proposal

The Company has submitted the Resumption Proposal to resume trading of its securities to Singapore Exchange Regulation on 30 June 2025 pursuant to Rule 1304(1) of the Mainboard Rules.

Trading of the Company's securities on the SGX-ST had been voluntarily suspended by the Company on 17 July 2023.

Shareholders of the Company and other stakeholders are advised to read this announcement and any further announcements by the Company carefully, and to exercise caution when dealing in the shares or other securities of the Company. Shareholders of the Company and other stakeholders should consult their stockbrokers, bank managers, solicitors, accountants, or other professional advisors if they have any doubt about the actions they should take.
