MONTHLY UPDATE PURSUANT TO LISTING RULE 704(23)

The board of directors of TA Corporation Ltd. (the "**Company**"), and together with its subsidiaries, (the "**Group**") wishes to update that there have been no material developments since the Company's last monthly update on 30 September 2025, save for the Company's announcements dated 7 October 2025, 29 October 2025 and 31 October 2025, and the following:

- (a) Further to the Company's announcements dated 5 September 2023 and 29 September 2023, Tiong Aik Resources (S) Pte Ltd, a subsidiary of the Company, was dissolved by creditors' voluntary winding up on 2 August 2025.
- (b) Further to the Company's announcement dated 3 May 2024 in relation to legal proceedings involving Credence Engineering Pte. Ltd. ("**CEPL**"), the parties to the legal proceedings, including CEPL, the developer, and the management corporation of the residential development ("**MCST**"), have reached an out-of-court settlement in relation to the claim on a full and final settlement basis. Pursuant to the settlement, CEPL will carry out remedial works for the defects which fall within the scope of its sub-contract, and MCST has discontinued its claim and shall have no further claims against CEPL. The Company does not expect the settlement to have any material impact on the financial position of the Group.

Trading of the Company's securities on the SGX-ST had been voluntarily suspended by the Company on 17 July 2023.

Shareholders of the Company and other stakeholders are advised to read this announcement and any further announcements by the Company carefully, and to exercise caution when dealing in the shares or other securities of the Company. Shareholders of the Company and other stakeholders should consult their stockbrokers, bank managers, solicitors, accountants, or other professional advisors if they have any doubt about the actions they should take.
